This Student is being assigned a Chromebook (may include a protective Case) for the 2021-22 school year. The Student is expected to maintain possession of the Chromebook (Case, if issued). The School shall retain ownership of the Chromebook (ownership does not transfer to Student). This Chromebook is both a required and necessary element of Student learning, in the same manner as a school textbook.

This Chromebook must only be used by the Student for whom it has been assigned. The Student shall not permit this Chromebook to be used by friends, other Students, or other family members. The Student must not use a School Chromebook which has been assigned to another Student.

All online Students must sign the School District Responsible Use Policy (RUP), which outlines the appropriate and inappropriate uses of district technology and resources. The RUP permits Students to use personal devices, if desired. If a Student chooses to use a personal Chromebook, the Student is encouraged to return the School Chromebook (to avoid costs for loss or damage of the device).

The Student has a responsibility to maintain proper care of the Chromebook and to store it in a protective case when transporting. Normal wear and tear (exterior scratches, minor dings) of the Chromebook is expected. Abuse, misuse, or neglect, which results in damage (broken case, keyboard, screen, power cord, corners, or interior electronic components), whether intentional or not, will result in repair costs. All repair costs shall be the responsibility of the Parent. The Parent may opt for School Chromebook insurance (see **Insurance & Repairs**). The School may render additional Parental costs or Student restrictions for loss or repeated abuse of a School Chromebook. Should a School Chromebook become damaged, a temporary replacement may be assigned by the School while damages are assessed.

This Chromebook shall be filtered by the Iron County School District network/firewall when the Student logs into the Chromebook and connects to the internet. While a Student may opt to use his/her personal device from home, personal Chromebooks cannot be used at School (they are not capable of joining the District network and cannot be filtered). Personal hotspots are not permitted at School.

At the conclusion of the 2021-22 school year this Chromebook (and Case, if requested by the School) shall be returned to the School from where it was originally assigned. The Chromebook will be assessed for damages. The Parent will be responsible for all repair costs. (See **Insurance & Repairs** options.)

Insurance & Repairs

The Parent has the option of purchasing (limited) School Chromebook insurance for the amount of **\$20 per year**, to be collected from the Parent at the beginning of each school year.

Accepting this option will insure this Student-assigned School Chromebook for the following repairs or circumstances, except for specific instances of **Misuse** (as is noted below):

Cracked or Damaged Screen \$50

Broken Keys or Keyboard \$4 each Key / \$20 Full Keyboard

Lost/Damaged AC Adapter \$20

Lost/Damaged Protective Case \$15

Full Chromebook Replacement \$250 (includes required Google Management License)

***Misuse:** This insurance option covers all repair costs, to include full replacement, should the School Chromebook (or other parts) stop functioning while under “appropriate” use. This insurance option does not cover the repair or replacement costs resulting from “inappropriate” use, which includes intentional or unintentional acts of destruction, loss or theft, or carelessness or other acts of malice, regardless of who has possession of the Chromebook (or other parts). Under all conditions identified (herein) as misuse, all repair or replacement costs will be the responsibility of the Parent, irrespective of whether the Parent has accepted this insurance.
